Elections – Director/Officer elections were held at our September 12th Membership meeting. There were no nominations from the floor. Larry Brown was re-elected for another term on the Board of Directors and Lannie Elderkin was elected to the new Secretary position.

Re-gravel of our Access Roads – This subject was again discussed at our Board of Directors meeting on September 12th. It was decided that the Association will hire and pay a contractor to re-gravel some of our access roads (access roads are those with tree names). For those who live on Bay Front Ave and other alleyways, you are asked to share the expense for re-graveling those specific areas. The schedule for access road re-graveling will be based on "worst roads first". Once we get costs and specific details, we will send out an email that describes how residents can take advantage of this bulk purchase to re-gravel adjacent road areas at a reduced cost by piggy-backing on the HPCA projects.

Anne Arundel Watermen's Association Calendar – The Anne Arundel Watermen's Association has created a calendar that captures life on the Chesapeake Bay. Piers - There are a number of piers in our community that have become littered with boards and debris as a result of damage from recent storms. In addition, there are loose boards that are hanging from these piers that are further loosened every time a wave hits them. **All this debris poses actual or potential hazards to navigation.** Some of these conditions have been left without repair or cleanup for a long time. As part of the Pier Agreement between each pier owner and HPCA, it is the owner's responsibility to maintain a safe pier structure. Those piers that are not in compliance with Federal, state and/or county requirements or the pier agreements will be identified and a notice sent to each homeowner. Please take action now to return your pier structure to a complaint condition.

Reminders:

- **Fire Lanes:** There have been a number of reports that the fire lanes in some areas are being blocked by parked cars for extended periods of time. Fire lanes include the un-graveled "paper" roads that lead to the waterfront. HPCA rules clearly state that **"Parked vehicles shall not restrict the fire lanes".** These blockages may impede emergency vehicles from accessing our community in the event of a fire (including accessing water from the Bay to fight fires) or other emergencies. Please comply so we can protect each other. HPCA will not hesitate to notify the police and arrange for those vehicles to be towed from the property at the owner's expense.
 - AIRB&B/VRBO owners please ensure that your renters are aware of where to park their vehicles.
- **Dog owners:** There is a leash law in Anne Arundel County. Dogs should never be running loose. When walking, please keep your dog on a leash and always pick up the waste. This makes for a pleasant walk on the Bay for everyone. Sorry that there is no comparable law related to the geese!
